# 2023 Finacial Report—Organization is Back on Solid Ground

#### **Our Mission**

Inspired by the compassion of Jesus, Caritas Connections, Inc. continues His mission to feed the hungry, clothe the naked, and help the sick, suffering and homeless.

In 2022, we had our first operating loss as a 501 (c)(3) charitable organization which we were able to cover with a healthy reserve balance. However, during the first half of 2023, the financial picture continued to look bleak: a reduction in donations combined with ongoing price increases due to inflation combined for a second year of anticipated deficit spending.

By June, we knew things had to change. So, the Board took a hard look at Caritas spending and enacted a 15% decrease in spending by our dedicated shoppers which went into effect in August.

We took several other proactive approaches to help offset the anticipated deficit. For the first time, we began actively pursuing grants. That hard work paid off when we were awarded a \$25,000 grant for COVID Relief Funding from the Missouri Department of Community and Economic Development.

We also took a new approach with donations, preparing customizable letters that board members and volunteers sent out to friends and family members who may not know about the good work that Caritas does helping the poor and underserved throughout the St. Louis metro community.

In November, a four-page article about Caritas Connections was featured in the St. Louis Review. We also informed our donors they were eligible to take advantage of the Missouri Food Pantry Tax Credit.

Combine all those activities and Caritas experienced a remarkable financial turnaround. By year's end, Caritas' total income, consisting of individual and corporate contributions, Gifts in Kind, annual Golf Tournament, and the \$25,000 grant was more than \$312,000. For the year, we spent \$279,000 on

food, clothing, personal care items, computer equipment, diapers, pullups and wipes and other supplies. So, we went from having a projected net operating loss of \$60,000 in June 2023 to a net operating gain of almost \$76,000 on December 31, 2023.

The additional funds we received have already been put back into our spending budget for our dedicated shoppers while still having an adequate amount of money set aside for unexpected needs.

As an organization, we have always kept our expenses as low as possible. Because Caritas has no salaried employees and because of donations of many required services, such as auto repair and warehouse space, we operate with extremely low overhead. Once again, our overhead was less than 5% of our total expenditures for the year. That means that for every dollar donated, more than \$.95 goes directly to helping the poor. That is a formula that we have no intention of deviating from now or in the future.

We are both grateful and blessed for all the donations we have received this past year. We are continuing to pursue funding through a variety of grants - but it is individual donations that are key to the continued success of Caritas which is why we ask that if you have given before, to please give again. Your donations truly allow us to help the poor and underserved - and there are so many more that we could be helping.

So, consider being a sponsor in the annual Caritas golf tournament. Tell those you know about the good that Caritas does. Make your donation go further by taking advantage of the Missouri Food Pantry Tax Credit. And if your employer participates in matching donations, please reach out to them.
